MUNICIPAL ORDINANCE NO. 086- 2020

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 082-2020 "AN ORDINANCE PROHIBITING THE SALE AND CONSUMPTION OF LIQUOR AND ANY KIND OF ALCOHOLIC BEVERAGES DURING THE NATIONAL STATE OF EMERGENCY, CRISIS OR DISASTER OR OTHER SIMILAR SITUATIONS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF"

WHEREAS, Municipal Ordinance No. 082-2020 " An Ordinance prohibiting the sale and consumption of liquor and any kind of Alcoholic Beverages was unanimously approved by Members of the Legislative Body last May 12, 2020 relative to the COVID 19 then reviewed and approved by Members of the Sangguniang Panlalawigan of Romblon and posted in three (3) or more conspicuous places of the Municipality;

WHEREAS, With the COVID 19 outbreak, the Legislative Body of Looc, Romblon Pursuant to Executive Order No. 20-2020 enacted Municipal Ordinance No. 082-2020 wherein the sale and consumption of liquor and alcoholic beverages of any kind is prohibited in the Municipality of Looc, Romblon since drinking of liquor and alcoholic beverages are usually done in close groups and in households that may cause

the spread out of the virus, as social distancing and limiting close contact from person to person is one of the primary means of avoiding the contagious disease.

WHEREAS, Effective June 1, 2020, the Inter Agency Task Force declared the Province of Romblon under MGCQ or Modified General Quarantine Relative to COVID 19;

WHEREAS, Given the current condition that the Municipality is COVID FREE and as we transition to the New Normal, the Legislative Body now amends certain provisions of Municipal Ordinance No. 082-2020 as follow;

NOW THEREFORE, Be it enacted and decreed, by the Sangguniang Bayan in Regular Session duly assembled;

Section 1. Title- This Ordinance shall be known as; "Regulating the Sale and consumption of Liquor during the State of National Health Emergency, crisis or disaster or other similar situation in the Municipality of Looc, Romblon.

Section 2. Prohibited Acts - The sale and consumptions of liquor and any kind of alcoholic beverages during the state of national emergency, crisis or disaster or other similar situation shall be prohibited if not in compliance with the following regulations;

- a. The Groceries, Liquor Stores, or such other High Volume Retailers shall limit the Daily purchases of Liquors, Alcoholic Beverages and other Intoxicating Products intended for Personal consumption per person in the amount as indicated or set forth in Page X under this Municipal Ordinance.
- b. That Sari-Sari stores or such other Low Volume Retailers shall limit the daily purchases of alcoholic beverages intended for personal consumption per person in the amounts set forth in Page X.
- c. That the Retailers shall require a purchaser of Alcoholic Beverages, Liquors and Other Intoxicating Product to present a valid ID for purchases intended for personal consumption or a valid Business Permits and Licensing Department, updated Business Permit or a Photo Copy thereof, for purchases intended for resale or redistribution of the above mentioned products.
- d. That the sale or distribution of Liquors, Alcoholic Beverages and Intoxicating Products are allowed only from 1pm to 8pm.
- e. That drinking or consumption of Liquors, Alcoholic Beverages and Intoxicating Products shall be allowed only within Private Residences for the duration of Modified General Community Quarantine (MGCQ).

Section 3. Enforcement- The Philippine National Police (PNP) of the Municipality is hereby mandated to enforce the full extent of this Ordinance as well as Barangay Officials and other Multipliers.

Section 4. Penalty- Distributors, Retailers, Person who violates any provision of this Ordinance shall be punished by a fine of not more than **Two Thousand Five Hundred Pesos (₱2,500.00)** or Imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the proper court without prejudice to the imposition of a higher penalty under the provision of existing Laws.


Section 5. - Any minors who will be apprehended in violation of this Ordinance will be turned over to Municipal Social and Development Officer as mandated on R.A. 9344 known as "Juvenile Justice and Welfare Act of 2006".

Section 6. - Repealing Clause - All Municipal Ordinances, Resolutions, Executive Orders, Memorandum inconsistent hereto is hereby repealed accordingly.


Section 7. - Effectivity - This Ordinance shall take effect upon approval of the Sangguniang Bayan of the Municipality and Local Chief Executive and posted in at least three (3) conspicuous public places for at least three (3) days. Copy furnish will be provided to the Office of the Sangguniang Panlalawigan of Romblon for review and approval.




