“AN ORDINANCE AMENDING THE LICENSE FEES OF BICYCLES AND BICYCLES WITH SIDECAR (PEDICAB) AND OTHER PARTS OF RESOLUTION NO. 44-1984 AND TAX ORDINANCE NO. 21 DULY APPROVED ON JULY 5,1984 BY INCREASING THE LICENSE FEE OF EVERY BICYCLE FROM TEN PESOS (₱10.00) TO FIFTY PESOS (₱50.00) AND EVERY BICYCLE WITH SIDECAR (PEDICAB) FROM FIFTEEN PESOS (₱15.00) TO SEVENTY PESOS (₱70.00) AND PROVIDING FUNDS THEREOF;

WHEREAS, Resolution No. 44 -1984 and Tax Ordinance No. 21 provided for License Fees of Bicycles and Bicycles with sidecar (PEDICAB) in the Municipality of Looc, Romblon;

WHEREAS, Section 1 of the Tax Ordinance No. 21 stated that Bicycle license fee increased from ₱5.00 to ₱10.00 and Bicycle with sidecar (**PEDICAB**) licensed fee will be ₱15.00 per annum;

WHEREAS, Section 2 of the Tax Ordinance 21 stated that the payment of Bicycle license fee will be on or before the 20th day of January and failure to pay on the said date shall pay 25% surcharge;

WHEREAS, Due to inflation rate of Philippine Money now a days and for more than 35 yrs. had passed there is a need to amend Sec 1 and Sec 2 state which part of Resolution No. 44-1984/Tax Ordinance No. 21 as adopted and approved on July 5, 1984;

NOW THEREFORE, Be it enacted and decreed by the Sangguniang Bayan, in Regular Session duly assembled;

SECTION 1. Title- That this Ordinance shall be known as "An Ordinance Amending the Section 1, Section 2 and other parts of Resolution No. 44-1984/ Tax Ordinance No. 21 regarding License Fees of Bicycle and Bicycle with sidecar (**PEDICAB**) in the Municipality of Looc, Romblon".

SECTION 2. Definitions of Terms:

a). Bicycle- means any device upon which a person may ride, which is propelled by human power through a system of belts, chain or gears, and which has two wheels at least twenty (20) inches in diameter and a frame size of at least fourteen inches (14 inch.)

b). Bicycle with Sidecar (PEDICAB**) –** means any device with seating for one or more persons which is propelled by human power through a system of peddles, belts, chains or gears and which has a three wheels.

c). Surcharge- an additional charge or payment.

d). License Fee- an amount of money being paid to LGU for Licensing of Bicycles.

SECTION 3. - That the amendments relative to Section 1, Section 2 and state which part of the Resolution No. 044-1984/Tax Ordinance 21 approved on July 5, 1984 are; The Licensed Fee of Bicycle from ₱10.00 per annum will be increased to ₱50.00 per annum and the Licensed Fee of Bicycle with sidecar (**PEDICAB**) will be from P15.00 to P70.00 and the Title Tax Ordinance 21 will be corrected as Municipal Ordinance No. 21-1984.

SECTION 4. IMPLEMENTATION- For Monitoring and regulation purposes, all bicycles and bicycles with sidecar (**PEDICAB**) owners/holders must register their units in the LGU. The Office of the Mayor, in cooperation with the Treasurer's Office and PNP shall have the control measures for the registration and inventory of the bicycles within the Municipality. All Bicycles being registered must be issued a Registration Sticker by the Office of the Treasurer to be attached on the visible part of the Bicycle Body and Issue an Official Receipt indicating the description of the Bicycle, Name and Address of the owner for record purposes and identification once the Bicycle or Pedi Cab is being stolen.

SECTION 5. PENALTY CLAUSE- failure to register the Bicycle or Bicycle with sidecar (**PEDICAB**) of the respective owners after Two (2) months that this Amendments of Resolution No. 044-1984/Tax Ordinance No. 21 is fully approved shall pay a Registration Fee with surcharge of 30%.


Section 6. All Municipal Ordinances, Executive Orders, inconsistent hereto is hereby repealed accordingly.

SECTION 7. SEPARABILITY CLAUSE- If any Part or provision of this Ordinance is declared unconstitutional, other section or provision of this Ordinance not affected hereto shall remain to be reinforced.


SECTION 8. EFFECTIVITY CLAUSE- This Ordinance shall take effect upon approval of Members of the Sangguniang Panlalawigan of the Province of Romblon and after posting in three (3) conspicuous public places of the Municipality.
