MUNICIPAL ORDINANCE NO. 24 - 2024

AN ORDINANCE PROHIBITING THE SALE OF VOLATILE SUBSTANCE/SOLVENTS TO MINORS IN ALL BUSINESS ESTABLISHMENTS IN THE MUNICIPALITY OF LOOC, PROVINCE OF ROMBLON

WHEREAS, One of the words that instil on the mind of Filipinos by Dr. Jose P. Rizal is that “ *Ang Kabataan ang Pag – Asa ng Bayan*”;

WHEREAS, however thi§ quoted words cannot be attained successfully for there are so many minors particularly in the City were addicted using solvent and volatile substances which is commonly known as “*Solvent/Rugby Boys*”;

WHEREAS, Source of this substances are the establishments particularly construction suppliers selling the above - mentioned substances even to the minors whose purpose is to “*Singhot*” but not on the actual use;

WHEREAS, to control addiction of this kind of substances to the minors in our Municipality there is a need to enact an ordinance to wit:

Be it Ordained and Decreed by the Sangguniang Bayan of Looc, Romblon in session assembled, that:

SECTION I. TITLE - This Ordinance shall be known as an *"Ordinance Prohibiting the Sale of the Volatile Substance/Solvents to Minors in all Business Establishments in the Municipality of Looc, Province of Romblon"*.

SECTION II. SCOPE - This Ordinance shall apply within the Territorial Jurisdiction of Municipality of Looc, Province of Romblon.

SECTION II. DEFINITION OF TERMS - for the purpose of this Ordinance, the following terms shall mean:

- a) Minor - any person who is below Eighteen years old (18)
- b) Solvent - shall mean to have based contact cement like rugby, vulca seal, fed seal, elasto seal, thinner and other similar materials, which can cause addiction.
- c) Establishment - any hardware stores, sari - sari stores or any establishment engaged in selling goods and products to include solvents.
- d) Logbook - A record book kept by a store or hardware containing information of customer names, address and purposes for buying a solvent products.

SECTION IV. REGULATORY ACTS

- a) Owners of commercial stores or business establishments shall be prohibited to sell volatile substance/solvents such as "rugby" to minors.
- b) Minors are prohibited to use rugby for addictive purposes.
- c) Business establishments are required to maintain a logbook where the name, address, and names, address and purposes for buying the substance shall be recorded.

SECTION V. PENALTY CLAUSE

1st Offense - Fine of Two Thousand Pesos (Php 2, 500.00)

2nd Offense - Revocation of Business Permit

SECTION VI. ENFORCEMENT - The members of the Philippine National Police, SK Officials and Barangay Tanods are hereby directed to ensure the widest dissemination and strict implementation of this Ordinance.

SECTION VII. FUNDING - An initial funding shall be allocated under the Peace and Order and Public Safety (POPS) Fund of this Municipality.

SECTION VIII. SEPARABILITY CAUSE - If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION IX. REPEALING CLAUSE - All ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION X. EFFECTIVITY - This Ordinance shall take effect immediately upon approval and after Fifteen days (15) posting in three conspicuous places of the Municipality.

Approved: 02 April 2024/ 6th Special Session.
